Allie: begins introductions of CCAC members, all citizens present, and county officials

Allie: After introductions, begins the meeting. Turns meeting over to Shawn Bird; Allie on Peachtree Board, recused herself due to conflict of interest

Approval of minutes: Tom Loach presents motion to approve September 2018 CCAC minutes, Doug Bates seconds the motion; all CCAC members present vote for approval. September 2018 CCAC minutes approved.

Peachtree Baseball Lights presentation:

- Peachtree Baseball and Softball intro slide
 - 501(c) 3 organization
 - Since 1956
- Growing need for space
 - Recreation league; want all to play, 10-12 games/season, 3 practices per game
 - Cal Ripken-Babe Ruth league - 500 kids in spring season; 64 pct increase since 2016
- How lights be used
 - Latest games start by 7:45 PM in summer; 1:45 max duration
 - Rain delays allow games played later
 - Lights to get in all games and practices; a few tournaments
 - All kids on these fields 7-12 years
 - Gives extra practice space; lights give 2 game in a night
- Lighting Plan
 - Minor Site Plan Revision
 - Crozet Park lower field is light location; LED lighting on Holzwarth Field
- Community Support
 - \$131K of \$140K raised in 8 weeks
 - Working with organizations to raise money
- Joe Forche with Musco Sports Lighting talk about Light Structure System
 - LED system
 - Approach every time: Safety, playability, and being a good neighbor
 - Configuration
 - Evolution 1977 to present (hiding light source, LED)
 - LED intense and needs to be hidden
 - Each LED in back, each visored
 - Pole heights, distance from field and hiding source
 - Rec 70 ft poles; 50 ft candles, and 30
 - 4 poles for lower field
 - Spillage 0.17 ft candle spillage
 - Great uniformity; eliminate glare for catcher and batter
 - Closest property line about 60ft
 - Min 40 percent savings energy

Doug - County restrictions on lights?

Jim - What nights lights on during the week?

Ben Jones, PT Board - Most nights in spring and couple tourneys; few weekends in June

Jim Duncan - penalty for over time?

Cheryl - no penalty now; will abide by county regulations

Joe Forche - schedule, monitor lights with cell phone app

Neighbor - support use; special needs child; in bed at 8; whole season every night - is there room for evergreens on two sides of the field; doesn't like the noise (swim meets); realistic pathway

Shawn - speaker placement: consider location; facing direction; weather systems

Neighbor - structural strength against wind?

Shawn: need a resolution?

Neighbor (Peachtree): submitted Minor Site Plan amendment to Albemarle County; in order

Kelly: community special; speaks well from fundraising perspective

Jennie: get the presentation to community; video, links; follow up on trees

Ann: any further notification of neighbors?

David: County should know regulation of notification

Ann: need a way to get word out

Downtown Crozet Initiative presentation:

Meg Holden - President of DCI

Live on small farm in Crozet; very different place; two options: pack up or engage in process; was on CCAC

Frank Stoner and Milestone Partners proposed this "concept." Community skeptical; let's engage them, what do they want; 3 years ago; started process of "Discernment;" public meetings, engagement

Gauge who can participate and engage; core group became DCI BoD; do development as phased plan rather than at once; community plaza idea born; find architecture firm; gathering to determine design

Who takes care of the plaza; become 501(c)3 organization; once part of CCAC; board of 5; goal of 15; Pat Groot great grant writer; meet monthly or bi-monthly; focus topics; DCI act as a economic development arm; Main Street Affiliate status; helps with Virginia Tourism; agri-tourism a natural for this area...

Developed a work plan; events; bring community together; increased Social Media presence; Fund Raising; 5K on 11.17.18; interest in Arts Center on the Plaza; construction ready to begin in last calendar quarter of 2019

Parking challenge once construction starts; DCI work with community to develop solutions; alternative parking solutions, work with county; initiate pedestrian safety campaign; want to make railroad a feature (example: Oakmont, PA)

Allie: progress on fence bump?

Frank Stoner - they are willing to move or eliminate entirely

Meg: Crozet a destination to live and come visit; use apps, etc.

Neighbor: plan to put sidewalks on Route 240?

Allie: on CCAC, county wish list

Sandra: why restaurants closed on Monday?

Richard: need to clean up back lot; fire department; proposals not doing anything for community; freedom of speech, issues

Joe Fore: parking or other things we can do to get approvals

Frank Stoner: thinking of when we can come back to the CCAC; come back in next few months; develop a code (most of county ARB does not apply); help DCI with guidelines for ARB; shuttle service

Jennie: monthly meetings of DCI - impressed how many people showed up (range of Old Trail to 250); have relevant topics; parking always of interest; tag places to determine conflicts and creative solutions - get people away from idea that you can park in front of stores...topic driven DCI meetings are great; how does community come together with County

Kelly: place where all of this info is available to go

Meg: fabulous website; go to apps; activity on FB, etc.

Neighbor: possible tax incentives to businesses for own parking?

Pat Groot: CCA advertise broadband survey; drum up competition

Discussion of All-CAC topics:

Allie: feedback from members on CAC topics; number 3 (Service Districts) came up a lot

Tom: work with other CAC on Master Plan implementation; for common areas come up issues for the county; Jim Duncan - small ideas brushed aside; onus to come together; had meeting with all CAC chairs; this year's All-CAC cancelled; accurate data important (Crozet population, growth expected); infrastructure keep up with development - not happened yet; growth vs. net density (ex: The View); goes through the list; allow CAC's to have Joint Resolutions - more voice in the Master Plan

Shawn: Joint Resolutions allowed currently?

Tom: resolutions defeated; times that issues appropriate for joint resolutions

Doug: opportunity here; support Service District; scrutiny on revenue sharing with Charlottesville

Tom: Chairs pare down; priorities for next year to the county; we prioritize for county

Joe: likes the idea of the topic ideas; get procedures right; need accurate data; need MP updates on time; gross vs. net precise

Tom: gross vs. net is an ordinance and can be changed; should context of master plan; Adelaide example

Jennie: timeliness of revisions, accurate data; colors vague; change how we do master plan; at PC, gross vs. net comes up; by-right projects; rezoning takes out flood plain, stream buffer don't count; if rezoning, The View would not exist, but it was By-Right; numbers different for rezoning vs. by-right; GIS mapping can be very exact; GIS changes number and hesitant to use

Tom: needs to be in context with community

Jennie: when moved into their home, was not aware of the calculations for density; embraced the growth

Allie: prioritize the list

Jennie: accurate data should be first

Allie: received responses; Valerie and David not supportive of CACs working together

Valerie: not exactly; focus on Crozet; caution against MP becoming too detailed; critical, but a general guide not a zoning ordinance; detail; makes hard to be flexible if

community wants to do it; community input; challenge to put Master Plan together; focus on Crozet MP; CACs different focus

Allie: will not make changes to MP here (at CCAC)

David: over stated; other CACs have competing agendas

Tom: disagree with issues of MP; less land available to develop, need more detail

David: detail should be at the site plan; different argument; concern with Charlottesville - neighborhood associations; city legitimized; made cost of houses in city skyrocket; opportunity to be a barrier instead of a facilitator of growth, housing and development of community - biggest concern; group together would be a block; cannot hold planner to future data

Jennie: come along way with data; staff does not have time; Crozet one of the first to get data; may not agree with methodology

Brian Day: we now have better maps; PC use the maps

Shawn: how often would CACs meet? Why will meeting not happen

Andrew Knuppel: want to make an all CAC meeting in February; listening to what CACs want for topics

Allie: send the list of agenda items to other CACs with reservations noted; welcome CCAC agenda items from members

Ann: mystery humming noise - not located but probably electrical wires; Eastern Avenue comment on long range transportation plan; comments welcomed on Long Range Transportation Plan; please support the work
