Allie: begins introductions of CCAC members, all citizens present, and county officials

Allie: After introductions, begins the meeting.

Approval of minutes: Tom Loach presents motion to approve June 2018 CCAC minutes, Kostas Alibertis seconds the motion; all CCAC members present vote for approval. June 2018 CCAC minutes approved.

Ann Mallek: Discusses CCAC fact sheet handed to all CCAC members; each member should understand CCAC roles. Background: there was angst about the Master Plan; BoS under some pressure on Master Plan issues, created Community Advisory Committees to help implement the MP.

Allie: CCAC meetings are not a place to change the Master Plan

Ann: people don't want another layer; BOS needs advice and discussion; will move faster on Master Plan update, which should be next year

Allie: after CAC discussion, begins items on the agenda with the Crozet Trails Crew.

Dan Mahon: Opens the presentation by saying that (Crozet) area trails were a place/something where every one could agree

Terri Miyamoto: CTC President, brief. Crozet Trails Crew....

- Goals
 - CTC Mission is to plan, build and prove multi-use trails in the Crozet community
- What We've Done Lately
 - New Trails
 - Improvements
 - Maintenance 2500 hours, mowers and pruners
 - Community Outreach
 - Communications FB, web, email

Dan - wants to connect Cory Farm next into the trails; ultimately connect Mint Springs to Lickinghole Basin

- What's Next
 - New Connections
 - Place-Making pocket parks, use flood plain, not 30 ft right of way
 - Western Park Trails
 - We can do this now, (not wait for new MP)
 - Big Dreams
 - Stroller friendly
 - Commuter trail Crozet to Charlottesville
 - Recreational trail to Blue Ridge Tunnel
- Challenges
 - It's not all beer and butterflies
 - Where can we build? Just because on MP, land may not be available
 - Trails often on land not suitable for building
 - Ongoing construction and, some trails on future developments
 - Need volunteers

- Appreciate Dan Mahon's efforts, help with easements
- Partnerships in the county (Stanley Martin, Riverbend, Marks Mountain

properties)

- Ann, Dan, and Bob attend Blue Ridge Tunnel Foundation meetings

Ann - what you can do; in the fall BoS, tell them to use money, not a bond referendum to catch up on things we've been waiting on for 20 years

Allie – introduces David Oberg, the White Hall representative on the Albemarle County School Board

David Oberg: Has been on the school board for three years; Allie asked (him) to come out to meet with CCAC; need action for overcrowded schools; last fall acknowledged that Western feeder pattern overcrowded; this is a planners issue; County has done a poor job of taking care of infrastructure; need to plan out for next 10 years

Tom: want to make schools larger or more schools?

David: Albemarle HS is overcrowded; Western is at capacity; \$120 mil for new HS; need plan for HS in 25 years; build "centers"; office centers internships or advanced studies; CATEC programs duplicated at a center or feeder schools; CATEC too far from Western

Allie: Are any more elementary schools planned?

David: no; none on CIP; expansion on Crozet Elementary a low priority; need \$96 mil now; will get half from BoS

Ann: Hard to explain centers; want to understand; it is one method; Albemarle County School System # 2 school system in state; budget now \$188 mil

Trails person: what you understand the growth to be? Educate us on the process.

David: The CIP with BoS; School Board proposes what they want; invest in more schools or expect that schools will be overcrowded; 7 cents increase tax is huge; do people want to pay for the increase of \$\$ for schools; formulas for neighborhoods to calculate #students

Joe Fore: hopes that BoS will hear what the School Board needs

David: we need to plan for future; need to grow our schools; fix the problem

Jon: wants to see priorities from the School Board

David: first \$1 mil on Henley security; secure facilities

Doug: wants more of an ongoing liaison with David and the School Board

David: important meetings held, but no one shows up;

Ann: 2008 there were a hundred people to speak about budget; now hardly any

Valerie: what can we do in economic development to help in our goals

Ann: get more from commercial development; invest to get businesses here; Orange Stop project - 620 families can't feed families

David: economic development essential to our kids; High School is not preparing our kids to get a job; School Board focus on internships and practical ability; it changes the academics; fundamental concern is the stress on kids (suicide, etc); Middle School and High School stress is (very) high; WAHS our kids are stressed and miserable; life skills important

Allie: Thanks David Oberg for talking with CCAC and community; let's start talk on CCAC topics

Tom: this is a good example why we need dialogue with other CACs; promote an action agenda at next group CAC meeting; what topics to submit other chairs and have meeting with county; develop a strategy

Rachel Falkenstein: next group CAC meeting early next year

Allie: send "All CAC" topics that are relevant to Tom

Tom: constant problem to get accurate data in growth in Crozet; if you don't know, then we can't plan

Kostas: need common themes and local

Tom: if you don't do it together, less effective

Ann: best growth numbers last year; planners can't predict until construction done; school respective in joint meetings, inaccurate

Ann: September 28 – Rivanna River Renaissance Conference at Lane Auditorium

Valerie: mentions end of summer event in Old Trail
