

Crozet Community Meeting (CCA) Minutes

May 9, 2019 at 7:30 PM
The Field School Auditorium

Welcome: Tim Tolson, President, welcomed 11 members.

Agenda Review: Jo Ann Perkins suggested an addition.

Approval of the CCA's last meeting's minutes (March 14, 2019). Jo Ann made the motion to accept and Ann Mallek seconded. Motion was unanimously approved.

Treasurer's Report (**2019 Dues: \$10 annual contribution**). Tim Tolson reported that there was \$3,670 in the CCA account and the Crozet Independence Day account had \$10,811. Fireworks have yet to be completely paid. (only down payment has been made)

Albemarle County Police Department (ACPD) may visit and give an update. (Evening Patrol Division) Officer Josh Mayberry introduced himself and gave statistics of speeding, crashes, burglaries, and aggravated assaults. Still a great place to live and raise children. There was encouragement to provide activities for the non-driving teenagers in the summertime.

A Moment in Crozet History – Phil James spoke on Crozet 1937 and what it looked like on the map. He spoke on how his family would "ride around the Horn in Crozet" aka centered around the Wayland property then. The product of Crozet then was FRUIT. He showed different highlights of Crozet in this "horn".

Update and News from Ann Mallek. Our county supervisor spoke on updates of coming events. No earthshaking news on developments. Ann also mentioned that The Green Olive Tree celebrated their 40th year Anniversary this week. Congratulations to a seven-lady group who developed the vision for the Green Olive Tree, which has been in continuous business in Crozet for 40 years.

Presentation: JAUNT Crozet Connect express shuttle service update, including preliminary/tentative routes and stops. (*Steven Johnson, JAUNT Planning Manager*) Stephen spoke on the commuter service between Crozet and Charlottesville. Launch date is August 5. He spoke on the considerations that they are handling to make this reasonable for pickups and deliveries to Charlottesville. He spoke on the sidewalks, road connectivity, and road congestion, job centers, schedule times, and most of all the need of community input. Stops will have signs. 23 passenger vans. They will have another meeting on May 15 at the Crozet Library at 7:00 PM about the CrozetConnect service.

Presentation: Crozet Master Plan update process (*Andrew Knuppel, Albemarle County Neighborhood Planner*). Andrew spoke on the beginnings of updating Crozet master plan for future land uses, transportation, parks and green space preservation. He hopes to identify key implementation projects and plans to use the data from the 2017 survey. The county staff will soon have a draft plan and it think it will take 18 months to get to adoption by the Board of Supervisors. They need and want lots of community input. Major themes are connectivity with roads, implementing a green network, downtown primary commercial center, and the need to clarify density/development along Route 250. The county wants to partner with the community, so the master plan is a community driven effort.

Old Business:

- Update from Blue Ridge Citizens Advisory Team meeting Wednesday, May 8. Tim showed their annual report and read some statistics from their report that sounded very promising for the community.

New Business:

- Good neighbor award nominations. David Wayland got the nomination if he has not gotten it before. Otherwise the CCA President will consult with past presidents to pick a recipient.
- Volunteers to help with Crozet Independence Day Celebration to be held Saturday, June 29, 2019. Can be fundraiser for civic groups, for example helping at the admission gate
- Jo Ann Perkins suggested a HEALTH DAY/WEEK in Crozet next May. Walking tours, special cooking shows, exercise by groups, hearing and other sensory screenings, and other creative ideas to improve our health as individuals and as a community.
- Jo Ann Perkins suggested a recycle center to be developed by the county and permit one end to house the Green Olive Tree.

Announcements –

Jennifer Kitchen introduced herself. She is a candidate for 25th District from Augusta County. She wants the rural voice to be heard. She is running for Steve Landis position.

The meeting adjourned at 8:58.

Crozet Community Association (CCA) Vision, Mission, and Bylaws

Vision: The Crozet Community Association welcomes, accepts, and celebrates all people, believing that equality and diversity exemplify the long-held ideals and values of Crozet.

It is committed to

- championing equality of worth among people;
- learning, acknowledging, and honoring the unique histories and lived experiences of all people; and
- standing united against any ideology of racial exclusion, superiority, segregation, or domination that perpetuates discrimination.

The mission of the CCA is to be:

- 1) a non-partisan forum for communicating information and issues associated with the quality of life in Crozet, VA,
- 2) a representative advocate for improving and maintaining a high quality of life within Crozet, and
- 3) a source to establish interest and action groups on areas of concern or interest to the community of Crozet. The CCA accomplishes this mission by working with residents, county / state representatives, community organizations (e.g. local homeowners associations, service organizations), and businesses.

Bylaws of the Crozet Community Association (CCA)

As last amended January 11, 2018

Article I: The CCA is a state corporation (*NOT a 501 (c)3 non-profit*) with volunteer officers and committee members. (P.O. Box 653, Crozet, VA 22932)

Article II: Officers will be elected for a one-year term, commencing on the first meeting of the calendar year immediately following their election. Positions will consist of President, Vice President, Secretary, and Treasurer. Candidates must be present at the election or have spoken with a current officer about their willingness to serve if elected. Majority approval by attendees at the first meeting of the calendar year will constitute election. Duties of the officers shall be as implied by their titles. All officers shall be responsible for keeping accurate records.

Article III: There will be 9 standing committees, which will meet independently of the CCA meetings and provide updates at each meeting of the CCA. They are as follows:

Committees may be eliminated or added as determined by the majority of attendees of a scheduled CCA meeting.

Article IV: Meetings will be held the second Thursday of the months of January, March, May, September, and November, and will generally follow Roberts Rules. Additional meetings may be called as determined by the President.

Article V: There will be annual dues collected each calendar year. The amount of the dues will be established and approved by attendees at a scheduled CCA meeting.

Article VI: Amendments to the Articles of Incorporation or these Bylaws may be proposed at any scheduled CCA meeting. Upon majority vote of approval, such proposed amendment must be placed on the agenda of the next regularly scheduled CCA meeting for a final majority vote for adoption. Such adoption shall become effective at the subsequent scheduled meeting following adoption.

Article VII: Motions made at a scheduled meeting in the conduct of the general business shall be voted upon and moved for adoption by a majority vote of those present. Motions on new matters or topics of general community interest or impact made at a scheduled meeting may be presented at any scheduled CCA meeting. Upon majority vote of approval, such proposed amendment must be placed on the agenda of the next scheduled CCA meeting for a final majority vote for adoption. The context of the motion will be communicated in the meeting minutes of the meeting in which it is presented and noted as being presented for vote of adoption at the next subsequent meeting.

Article VIII: A quorum of 10 percent of the members who are current in their dues shall be required to conduct business at any meeting of the CCA.

Article IX: Roberts Rules of Order Newly Revised shall govern the CCA conduct of meetings where they are not inconsistent with these Bylaws.
