Chair Allie Pesch called the meeting to order at 7:02

The members of the Committee introduced themselves.

Noting that a quorum was present, the Committee approved the February, 2022 minutes following a motion to approve by Brian Day, and a second by Kostas Alibertis.

The Committee welcomed new member Jim Duncan

<u>Presentation: Transportation Planning Overview & Crozet Project Updates:</u>

Kevin McDermott, the Planning Manager for Transportation provided a presentation that covered the following transportation planning topics:

- The early planning process
- Project prioritization based on specific metrics
- Funding mechanisms/sources:
 - Smart Scale primary funding mechanism, applications scored and ranked. Very competitive
 - Revenue Sharing Program less competitive, but requires 50% funding match by the County, up to \$10 million total

- Transportation Alternatives Federal funding for projects that expand non-motorized transportation projects (bike, ped typically). Requires 20% local match
- Secondary Six Year Plan annual allocation of State funds mostly to pave unpaved roads
- State of Good Repair primarily for bridge and road rehabilitation and replacement projects.
 Projects are identified by VDOT, not the County
- Highway Safety Improvement Program road/bike/pedestrian improvements related to safety. Identified by VDOT, scored and ranked
- Other Federal/State Funding Opportunities RAISE, LWCF, Federal Lands Access Programs, Economic Development Access Programs, etc.
- Local Funding Mechanisms:
 - Capital Improvement Program (CIP) funds, which can be used to locally fund a project, or applied to a Smart Scale application to increase its score and ranking
 - Developer Funded/Constructed Improvements via proffers or conditioned improvements and/or funding to address impacts of their development, or improvements constructed by developers as part of their development
- Project Implementation -
 - Locally funded projects can be constructed relatively faster (3-5 years) compared to State or Federal Funds. Smart Scale projects take approximately 8-11 years.

Crozet Project Updates:

Eastern Avenue South Extension -

- Will connect Eastern Avenue through Corey Farm to Route 250
- Submitted for revenue sharing grant; will find out in April if funded
- Project is significantly expensive -- ~ \$25 million

Route 240/250 Roundabout

- State administered project
- Delays have occurred, but construction estimated to start by the end of 2022.

Old Trail Drive/WAHS/US 250 Roundabout

- Learned during Crozet Master Plan that this was the worst-performing intersection in Crozet
- Will be submitted as a Smart Scale project in this round
- Will find out in 2023 if it is funded

Break for Q&A:

There was a question about the process for construction when there is a need to acquire land from a private landowner. Kevin provided a brief explanation of the process, noting the effort to negotiate a fair and equitable agreement on the compensation amount.

- Supervisor Mallek noted that the boundaries of the Eastern Avenue connection have been established for many years, and signs have been posted to make the public aware that the road will be extended/connected in the future once funded.
- Kevin noted that this is expected to be a VDOT-administered project

There was a question about whether there will be a signal where Eastern Avenue will intersect with Route 250. Kevin provided several responses and comments:

- When it was initially studied, the study did not show a signal was needed, so most likely one will not be installed when the road is completed.
- But they will monitor it just as they do with every other intersection, and when VDOT determines it is needed it could be installed then.
- The signal would be prioritized if shown to be a documented safety issue

- There was a comment about how Corey Farm residents already have a hard time turning left out of Corey Farm
- Supervisor Mallek encouraged the intersection to be pre-wired for a signal for easier installation when authorized.

There was a question about how cost estimates are calculated and managed given expected price increases in the future

Kevin explained that their cost estimates factor in expected cost increases; the estimate is the
estimated cost to construct it at the time construction would start. But recent cost increases are
more significant and challenging, which could require additional funding, either from the State or the
County.

<u>Projects Constructed by the County Facilities & Environmental Services Department</u> – presentation by Lance Stewart

US 250 West Sidewalks

- Rt 250 in front of Harris Teeter, Corey Farm, and Clover Lawn
- Sidewalks and mid-block crosswalks planned
- Schedule: estimated to be complete by August 2022
- There will be some road closures weekdays during approximately 9 am 4 pm

Crozet Square and Oak Street Improvements

- Improvements to the Square in front of Fardowner's and to Oak Street
- Full build-out of Oak Street, including with formal parking.
- Project includes: new sidewalks, ADA compliant parking lot, drainage structures
- New traffic flow at the signal at Crozet Ave.
- Design is still preliminary, at 60% stage now, it will continue
- Schedule estimate: 6-8 months to get to point of issuing bids, then 2-3 months for that process, then award contract. Estimate of one year to construct from contract award date.
- Sidewalks and bike infrastructure will be part of the next phase of design

Barnes Lumber Redesign:

- No formal parking at first, just road network.
- Multi-use path would be included eventually
- Status: nearing 60% design, which is major threshold point
- Numerous utility lines must be relocated

Questions and Comments:

- A member of the public commented on long-range planning and coordination of development and road, bike, and pedestrian infrastructure
- Another member of the public asked whether a pedestrian tunnel would be part of the proposed 250/Old Trail Drive/WAHS roundabout.
 - Kevin noted that pedestrian safety will be a critical safety component of the design.
 - But an underground tunnel is challenging due to grade differences and cost.
 - He reminded the group that because cost is one of the factors that are scored, the higher the cost of a project, the less likely it is to be funded; so there is a delicate balancing of goals.
- There was a question about estimated future population numbers.
 - Kevin notes it was part of the research at the start of the Crozet Master Plan
 - The development dashboard historically has tracked this, but staff shortages have not enabled it to be maintained, but that the data is tracked by staff
 - Kevin noted that the data was included in the traffic Study that was part of the Master Plan update. The traffic study is an appendix to the Master Plan.
- Kevin provided an additional explanation about the traffic signal approval process

- A member of the public commented on the County GIS system

<u>Crozet CONNECT update & discussion</u> – Presented by Kelly Fomenko of Jaunt

- Provided a history of, and an update on the service
- Service continues to be fare-free, no current plans to resume charging fees
- JAUNT is looking for feedback on bus stop locations, schedules, and procedures to identify ridership needs and to improve existing service
- The survey is looking for updates on:
 - o Telecommuting status
 - Safety concerns
 - Changes in work schedules
 - Location and employment changes
 - General familiarity with the service
- Survey runs through March 25

- A few minor changes to the schedule were explained, which are noted on the Jaunt website

There was a question about the status of the former TONY autonomous trolly. Kevin explained the County owns the trolly, but funding challenges limit required software updates needed to operate it.

There was a question about service in the northern part of the County. Kelly noted there is service, but funding technicalities may result in changes, and Charlottesville Area Transit is planning for future service.

Upcoming CAC Topics – Rachel Falkenstein

- Rachel shared a tentative 2022 meeting schedule, which is posted below
- Alternating specific topics every other month, and in the off-months use the meeting for community meetings for development projects as needed.
- If a development project community meeting is not scheduled, the CAC meeting would be cancelled
- This will also allow for CAC participation in the County-wide Comprehensive Plan update
