3. **Albemarle County Transportation Presentation (75 minutes)**

Kevin McDermott, Albemarle County Deputy Director of Planning

- All roads and right-of-ways are VDOT owned/maintained, but works with Albemarle County for planning, new projects, and improvements.
- All new projects above a certain impact require a traffic impact study
- Albemarle County Transportation works to create a comprehensive plan, prioritize projects, request funding, and implement projects.
- Funding typically comes from local (CIP), state (SMART SCALE), and federal (RAISE/BUILD) sources.
- Projection Implementation process flows from design to right-of-way acquisition to construction.
- Update on current projects in our area:
 - Crozet Square / Oak Street Improvements
 - Substantially Complete
 - Stoplight at Crozet Square will be adjusted to trigger for pedestrian requests
 - Library Avenue Extended & Barnes Lumber Road Network
 - Complete Summer 2027
 - US 250 / Rt 240 / Browns Gap Turnpike Roundabout
 - Opens by early February 2026 / Complete by August 2026
 - I-64 Exit 107 Crozet Park & Ride
 - Begin late Spring 2026 / Complete December 2026
 - Old Trail Drive / US 250 Roundabout
 - Prior SMART SCALE applications just missed funding threshold
 - Upcoming application due by August 1, 2026 with funding decision

Spring 2027

- Eastern Avenue South Extension
 - County is seeking options since open bid process in 2025 yielded one bid and that developer opted not to move ahead
 - Considering a design-build procurement process that is linked with the Boulders Road Extension (Rivanna Futures) to make the scale of the project more appealing to contractors
 - CIP money is set-aside for this project
 - Three Notch'd Trail Share Use Path Master Plan
 - Planning process has started
 - Currently soliciting feedback from community stakeholders to identify preferred routes
4. **Board of Supervisors/Planning Commission Liaison Updates (5 minutes)** – this is time reserved for liaisons to share community announcements and project/policy updates
Planning Commissioner Lonnie Murray
- Revisions to form-based code is under discussion
 - Belvedere asked for increased density, but applicant ultimately deferred request
5. **Other Committee Business (10 minutes)**
- Lee Kondor requested to attend a future meeting to survey residents about the cost of their private trash and recycling services to determine if the county should consider providing the service.
6. **Community Concerns (10 minutes)**
- During general meeting discussion, community members expressed concerns/thoughts about the following:
 - Crozet Square right-in/right-out isn't being followed by drivers
 - There's a light pole in the middle of the alley near Crozet Square
 - Some residents in neighborhoods where trash/recycling is included in the dues noted that Mr. Kondor should reach out to HOAs, too.
